2 EXPLANATORY NOTES

- 1. A seperate confirmation must be completed for each customer (e.g. joint holders, trustee cases and life cases). Where a third party is involved, e.g. a payer of contributions who is different from the customer, the identity of that person must also be verified, and a confirmation provided.
- 2. This form cannot be used to verify the identity of any customer that falls into one of the following categories:
 - a) those who are exempt from verification as being an existing client of the introducing firm prior to the introduction of the requirement for such verification;
 - b) those whose identity has not been verified by virtue of the application of a permitted exemption under the Money Laundering Regulations; or
 - c) those whose identity has been verified using the source of funds as evidence.
- 3. A politically exposed person (PEP) is defined as an individual entrusted with prominent public functions. This includes (but is not limited to) heads of state, government ministers and deputy ministers, members of parliament or similar legislative bodies, and senior members of the military and judiciary.

A known close associate of a PEP is defined as including:

- an individual known to have joint beneficial ownership of a legal entity or a legal arrangement or any other close business relationship with a politically exposed person
- an individual who has sole beneficial ownership of a legal entity or a legal arrangement that is known to have been set up for the benefit
 of a PEP
- 4. This confirmation must carry an original signature.
